### Planning Applications Discussed

**Application No:** FUL/MAL/14/00493

**Proposal:** Replacement dwelling - demolition of existing bungalow with garage and proposal to construct new house and garage

**Location:** Fieldway Station Road Wickham Bishops

The Committee noted that the proposed new house would be sited closer to the neighbouring property Meadowbank.

**Recommendation:** APPROVE with the following conditions:

- Slab to be no higher than the existing bungalow;
- Fixed, obscure glazing to be used in the window of the first-floor bathroom facing East towards Meadowbank;
- Suitable screen planting to be used at the boundary with Meadowbank.

**Application No:** FUL/MAL/14/00426

**Proposal:** Provision of an entrance gate and parking for two vehicles

**Location:** Likely Wood Wickham Hall Lane Wickham Bishops

**Recommendation:** APPROVE with the following conditions:

- No commercial use;
- Passing place to be retained and suitably surfaced;
- Suitable porous materials to be used and approved by the local authority;
- Consideration to be given to the fragile nature of Wickham Hall Lane, in regards to sizes and weights of delivery and works vehicles.
