<b>19P/038</b>	<b>Those Present and Apologies for Absence</b> In the chair: Cllr MacGregor Present: Cllrs Mundell and Wardrop; the Clerk. There was one member of the public present.
<b>19P/039</b>	<b>Declaration of Interests and Compliance with the Ethical Framework</b> There were no declarations of interests.
<b>19P/040</b>	<b>Public Forum</b> A member of the public spoke on behalf of their client's application <i>19/01027/FUL - Land East of Hornbeams Blue Mills Hill</i> , explaining that the re-siting of the transformer would give good, safe access for maintenance, remove an unsightly pole and provide resilience for the power distribution network.
<b>19P/041</b>	<b>Planning Applications</b> <b>19/01027/FUL - Land East of Hornbeams Blue Mills Hill Wickham Bishops</b> One letter of support, from the applicant's agent, had been received.
